What is the registration deadline date?

Where is the SIRM General Assembly being held?

<u>For SIRM members only.</u> The SIRM General Assembly is being held on 11 June 2024, at the MSC Cruises offices, Av. Eugene Pittard 16, Geneve from 12pm to 3.15pm. After the General Assembly all participants will be invited to go to the Beau Rivage Hotel by complimentary bus transfer (15min).

When and Where is the SIRM Geneva Rendez-Vous being held?

The SIRM Geneva Rendez-Vous is being held on 11 June 2024, at the Geneva Beau Rivage Hotel, Quai du Mont Blanc 13, Geneve, 3.45pm – 8pm.

What are my ticket options?

- <u>SIRM member: General Assembly only (12pm-3.15pm at MSC):</u> You need to be a SIRM member to select this ticket.
- <u>SIRM member: Geneva RDV only (3.45pm-8pm at Hotel Beau Rivage):</u> You need to be a SIRM member to select this ticket.
- <u>SIRM member: General Assembly (MSC) + Gen. RDV (Beau Rivage):</u> You need to be a SIRM member to select this ticket. All participants will be invited to go to the Beau Rivage Hotel by complimentary bus transfer (15min).
- <u>SIRM non-member (Risk Managers) Geneva RDV (3.45pm-8pm at Hotel Beau Rivage):</u> For the risk managers who are not members of SIRM.
- Partners: Geneva RDV (3.45pm-8pm at Hotel Beau Rivage): For the 2024 sponsors only (Insurers, Brokers, etc.)

What is included in my ticket?

- o For The General Assembly at MSC Cruises: Lunch and bus transfer to Geneva Beau Rivage Hotel
- For the Geneva Beau Rivage Hotel: apero riche and drinks until 8pm. Attendees are welcome to stay at the Hotel terrasse past 8pm, additional drinks will be available for purchase at the bar.

When planning my travel arrangements, when should I schedule to arrive and depart?

- The SIRM General Assembly begins on Tuesday 11 June at 12pm and concludes at 3.15pm.
- The SIRM Geneva Rendez-Vous begins on Tuesday 11 June at 3.45pm and concludes at 8pm.

What are the ground transport arrangements?

o For The General Assembly at MSC Cruises:

- o <u>TO</u> MSC cruises, you are responsible for all transportation:
 - The bus stop is Aubert (from Gare Cornavin: Bus 8 & 20 direction Veyrier)
 - Train (TER) stop is Geneve-Champel
 - Walking distance from Cornavin main railway station: 45 minutes

o FROM MSC cruises:

- all participants will be invited to go to the Beau Rivage Hotel by complimentary bus transfer, no reservation required (15min).
- participants with their own car can use the Hotel Beau Rivage Parking at their own cost (details below)

- Beau-Rivage Hotel Parking

Beau-Rivage has a limited number of parking spaces (10 spots only). They can be booked ahead, in which case please contact reservation@beau-rivage.ch. Cost is as follows:

- CHF 20 per car: up to 4 hours of parking
- CHF 30 per car: after 4:00 a.m. until 12:00 p.m. parking
- CHF 45 per car: beyond 12 hours of parking, daily rate
